# JOB PURPOSE

An instructor at The Literacy Coalition's Learning Center is responsible for the instruction, progress, and management of adult students in online and in-person classrooms. Instructor must be able to assist students with both high school level Reading/Language Arts & Mathematics and ensure that students gain the knowledge and skills that are required to pass the GED/HISET test.

Instructors must implement sound educational practices and see to the academic development of each student. Instructors will also manage their classroom environment and promote a positive and engaging learning experience, provide support, tutoring and other assistance as needed. Instructors are to "model" the professional behaviors, language, and activities expected of our students.

## **ESSENTIAL FUNCTIONS**

## **Instructor Duties**

- Instruct students in an understanding, patient, and engaging manner.
- Maintain copies of curriculum, make changes to curriculum under advisement of Lead Instructor, and modify curriculum to meet individual student needs.
- Keep track of individual student progress for weekly staff meetings.
- Proctor baseline and progress testing for students.
- Record student enrollments, tests, gains, exits and completions in grant databases.
- Tutor students one on one in-person and via Zoom in math, science, social studies, and reading/language arts.
